SHORT QUOTATION NOTICE

Sealed Short Quotations are invited from bonafide resourceful agencies/contractors for providing 24x7 Security Services in the Gomati Cooperative Milk Producers' Union Ltd. on Annual Contract. Quotationer should have the State Government registration/license for providing such security services in Tripura and also they should have the experience of providing security services for at least last three consecutive years (i.e. providing security services through Ex-servicemen/ Civil Guards) in Large Educational/ Research Institutions, Universities/factories run by Central Government/ State Government Departments, Public or Private Sector Companies/ Undertakings, Autonomous Bodies.

The bidder must have a valid (as on bid submission date) license for security services of Tripura State Government Security Agency Regulation. The Quotationer should have the registration in Income tax, EPF, ESI, GST. The Quotationer should be registered under Contract Labour Act, and should be valid at the time of bid submission date.

The Quotationer should submit the experience certificates at least from three large institutions in Tripura for last previous three years and also should submit the copy of such work orders. The Quotationer should have sufficient employees on its own specifically trained for Security works.

The Quotationer should submit the following documents along with the quotation:

- (a) The copy of Firm's Registration / Incorporation Certificate with relevant authority in the state.
- (b) Self-attested copy of valid license for security services of the private security agencies.
- (c) Self-attested copy of valid registration certificate under Contract Labour.
- (d) Income Tax clearance certificate of last financial year.
- (e) Self-attested copy of GST registration certificate and PAN card.
- (f) Self-attested copies of Work Orders or Client's Satisfactory Certificates.
- (g) Experience certificate from three large institutions in Tripura for last three years.
- (h) Authenticated documents in support of EPF and ESI.

The above documents must be attached with the quotation, failing which the quotation will not be considered.

The quoted rates will be inclusive of all taxes etc. and allied charges, if any.

The contract shall be valid for a period of 12 (twelve) months from the date of commencement of services. The contract can be extended on successful completion of the service.
