All documents viz. copy of Aadhaar, Factory RegistrationCertificate, IT return of previous three financial years, Turnover of last three years duly signed and sealed by Chartered Accountant,Ownershipdetails/Partnership Deed,BISLicenseCertificate,ISO certification, Trade License, State Pollution Control Board Certificate, FSSAI Certificate, MSME/UDDYAM AADHAR Registration Certificate, Manufacturing Capacity documents, GST Registration etc.should be submitted along with the proposal of expression of interest (Check-List of documents attached).
- 2. Declaration to be furnished by the manufacturer that the manufacturer has ability to provide bottles/Jars, labels, caps, cap sleeve, shrink sleeves, cartons etc. packaging and printing arrangement etc. as per requirement of GCMPUL whenever necessary. The drawing, design of label, carton etc. to be developed at the cost of the manufacturer. Final developed design is to be approved by GCMPUL.
- 3. Declaration also to be furnished by the manufacturer to provide transportation at the cost of manufacturer to the desired location of GCMPUL within Agartala. The manufacturer should also arrange loading, unloading of the materials at his cost.

- 4. Self-declaration in respect of having 3(Three) yearsexperience of manufacturing and marketing of packaged drinking water is to be furnished with supportive documents.
- 5. Self-declaration in respect of Manufacturer having arrangement for chemical and bacteriological testing of water in his own factory.
- 6. A layout plan with location of Manufacturers' plant/premises of Packaged drinking water is to be furnished and shall be open to GCMPUL for inspection, if necessary.
- 7. Manufacturing Capacity of the Manufacturers' plantis to be furnished and shall be open to GCMPUL for inspection, if necessary
- 8. Consent declaration from the manufacturer to enter into an agreement with GCMPULfor such work, for a period of one year or as decided by the GCMPUL.
- 9. Declaration in respect to provide free samples of bottle/jar, ifnecessary as desired by GCMPUL.
- 10. Declaration in respect of credit facility (minimum one month) against supply of customized packaged drinking water should be given to GCMPUL (Form-II attached).
