The competitive unit rate (per person) inclusive all for providing semi-skilled and unskilled Security Guards is to be clearly mentioned in the submitted quotation.

Quotationer must superscribed the sealed envelope with "Quotation for Security Guards" and addressed to the Chief Managing Director, Gomati Cooperative Milk Producers Union Ltd., Agartala Dairy, Indranagar, Agartala, Tripura with contact number.

Quotationer must have registration/license for providing such security services from the Government of Tripura and also they should have the experience of providing security services for 3 (Three) years (i.e. providing security services through Ex-servicemen/ Civil Guards) in Reputed Educational/ Research Institutions, Universities/factories run by Central Government/ State Government Departments/Banks/ Financial Institution/ PSU/Autonomous Bodies.

The Quotationer must have a valid (as on bid submission date) license for security services of Tripura State Government Security Agency Regulation. The Quotationer should have the registration under Income tax, EPF, ESI, GST. The Quotationer should be registered under Contract Labour Act, and should have validity of 3 (three) months at the time of submission of quotation.

The Quotationer should furnish experience certificates from those institutions/ organizations etc. in Tripura, where they have provided security services for last previous 3(three) years and also should submit the copy of such work orders. The Annual turnover of the Quotationer should be minimum of Rs. 60 Lakhs per year for last 3 (three) years

The Quotationer should submit the following documents along with the quotation:

- (a) The copy of Firm's Registration / Incorporation Certificate with relevant authority in the state.
- (b) Self-attested copy of valid license for security services of the private security agencies.
- (c) Self-attested copy of valid registration certificate under Contract Labour.
- (d) ITR acknowledged of last 3(three) financial year.
- (e) Self-attested copy of GST registration certificate and PAN card.
- $(f) \ \ Self-attested\ copies\ of\ Work\ Orders\ or\ Client's\ Satisfactory\ Certificates.$
- (g) Experience certificate from the institutions in Tripura for last three years.
- (h) Authenticated documents in support of EPF and ESI.
